AUDITORS REPORT

INDEPENDENT AUDIT REPORT TO THE MEMBERS OF V.A.F.A. UMPIRES ASSOCIATION

Scope

I have audited the financial statements of V.A.F.A. Umpires Association for the year ended 31 October 2004.
