Comments: President's comments;

- New Women's Academy announced for 2019
 - o UA initiative with VAFA to grow female participation and membership
 - O Aim to recruit 20 new female umpires per year into the program
 - o Provide funding for uniform, dedicated coaching/mentoring and equipment
 - Program led by Hannah Bailes, assisted by Alexandria Anthony and Asha Hinton, with support from Russell Davidson
- 2018 was a year of significant change, with most of the committee's time spent re-establishing an efficient working relationship with HQ after significant personnel changes
- 2019 negotiated a 3-year pay deal, including benefits such as physio at training, continued free access to finals, and increasing 3 umpire matches
- Introduction of OSH section of matchday paperwork
- Continued work with VAFA/Oms on the use of the HQ Social space
- Seeking to increase our member value through sponsorships and discounts
- Financial Strategy;

- 2013-2017: Strategy to move towards autonomy. This has been completed by repaying all loans and building sufficient working capital to undertake all association activities and buffer for facility issues
- 2018: return 2018 received funds to the members through programs. Increased subsidy for awards night, Food provided at every Wednesday training session.
- 2019: Continue to look at programs to return best value. Continue to grow sponsorship. Direction in future years will be dependent on building discussion following.

Treasurer's Report

Comments: Treasurer's comments;

- Year ended 21st October 2018 Net Deficit \$8,056 (2017: Surplus \$9,795)
- Changes from 2017 include:
 - Additional subsidy towards pre-finals event in 2018 of \$8,885
 - Free Wednesday night meal (\$4000 less takings from members)
 - Engineering services cost (\$1,155)
- Cash at Bank 31st October, 2018 \$47,692
- 2019 Forecast:
 - o Anticipated surplus approx. \$1,000 \$3,000
 - Key assumptions include
 - Reduced subsidy towards PFD \$10,000 opportunity
 - Increased sponsorship income in 2019 \$6,750 to \$11,750
 - Offset by costs associated with establishment of Womens' Academy
