## **Report from the VAFAUA Treasurer**

#### **Comments:**

Treasurer's comments were read by Josh Colman on behalf of the immediate past treasurer, Mitsuo Nire.

Year ended 31st October 2019 – Net surplus \$935 (2018: Deficit \$8,056)

Predicted surplus, as presented at 2019 AGM, of between \$1,000 and \$3,000, was at the lower end of expectations

- Changes from 2019 include:
- Reducing the cost of uniforms (goal umpires in particular)
- Free Wednesday night meal for all training sessions (\$4000 less takings from members)
- Increased cleaning costs of the UA Pavilion (\$1289 more)

Cash at Bank 31st October, 2019 - \$28,721

Total Assets at 31st October, 2019 - \$134,930

#### **Increases**

- Gear Sales (\$14,449 more than 2018)
- Sponsorship (revenue from sponsorship increased by \$10,363 more than last season)
- Expenditure (more than 2018, largely due to increase in money on social/PFD subsidies etc)

#### **Future**

- Overall current and total assets very similar to previous years
- Net cash and cash equivalent also similar
- No outstanding loans
- Healthy financial position, despite no season
- Money we planned to have available for 2020 season we plan to have available for 2021 season

Safety precautions for next season

- Current protocols would make it difficult for footy to be played
- Restrictions around change rooms in particular are going to be difficult to enforce in their current form
- We still aren't sure what next season will look like

#### Honoraria

Suggestion raised about providing the social secretary an honorarium

• Social Secretary honorarium for next financial year confirmed earlier this season

### **Financial Position**

- Almost on par with where we were last season
- Small amount of gear sales have kept us from moving up or down
- Money from debtors has put us in better position now
- We will be able to fully support season 2021

#### Match Fees

- There will be no cut for 2021
- 2021 pay will be higher than in the 2019 season for Home and Away and Finals Matches.
